## STANDING ROCK SIOUX TRIBE EXECUTIVE ORDER

### CORONA VIRUS AWARENESS

During this time of the pandemic COVID-19 virus and in an effort to slow the spread of the virus on the Standing Rock Sioux Indian Reservation, it is imperative that we take actions and precautions to limit our exposure to the virus.

In an effort to address and limit our exposure to the virus and by the authority granted to my office through Title XIX, Section 301, it is my duty to remind our people that we need to protect our children and the general public.

The Standing Rock Sioux Tribe, Code of Justice, Section 6-501 places hours of Curfew for all children under the age of eighteen (18) years of age. Through this Executive Order, I hereby declare that although our Children are being asked to stay at home, we are still in a School year. The following hours of Curfew will be in effect:

- During the school year the hours of curfew shall be between 9:00 o'clock p.m., C.D.T. and 6:00 o'clock a.m., C.D.T. for children 14 and below;
- During the school year the hours of curfew shall be between 10:00 o'clock p.m., C.D.T., and 6:00 o'clock a.m., C.D.T. for children ages 15, 16 and 17.

I hereby declare that the hours of Curfew shall be in effect on a daily basis, without regard to weekends. A child shall not be deemed to be in violation of curfew hours if they are with their parent(s) or guardian(s).

Also, in an effort to limit the spread of the virus and for the safety and well-being of all of our people, I hereby urge all people on the Standing Rock Sioux Indian Reservation to **SHELTER IN PLACE** as much as possible. This Shelter in Place requests all residents to stay indoors except for certain essential activities, which include buying food, gas and seeking medical treatment. We all must be vigilante and do as much as possible to limit the spread of the virus.

Due to the changing conditions of this virus and the fluid situation this virus has created, this Executive Order is subject to change at a moment's Notice
